Did you know.....

WV does not currently have any regulations for medication disposal in a childcare setting. It is recommended that your facility have a policy in regards to when unused/expired medications should be disposed. Best practice is to return to the child's parent/guardian. If unable to do so for any reason, don't risk becoming a medicine cabinet for storage of needless medications. Expired and unused medications increase the risk of medication errors! Check out these tips from the www.smarxtdisposal.net website to safely remove unnecessary medications from your childcare setting.

- On prescription bottles, the label will often tell you when the medicine should be discarded. On over-the-counter medicines and sample medicines, the expiration date (the date it should be discarded) is often printed on the label under "EXP," or stamped without ink into the bottom of a bottle, carton, or the crimp of a tube.
- As time passes, medicines may lose their effectiveness. In rare cases, outdated medicines could become toxic. For example, taking expired tetracycline (an antibiotic can cause serious kidney problems).
- DO NOT FLUSH unused medications. Consumers were once advised to
 flush their expired or unused medications; however, recent environmental
 impact studies report that this could be having an adverse impact on the
 environment. While the rule of thumb is not to flush, the Food and Drug
 Administration (FDA) has determined that certain medications should be
 flushed due to their abuse potential. Read the instructions on your
 medication and talk to your pharmacist.
- When tossing unused medications, we need to protect children and pets from the potentially negative effects. Crush solid medications or dissolve them in water (this applies for liquid medications as well) and mix with kitty litter, coffee grounds, or sawdust (or any material that absorbs the dissolved medication and makes it less appealing for pets or children to eat), then place in a sealed plastic bag BEFORE tossing in the trash. (The nurse also recommends that in the childcare setting medication that has been thrown in the trash should be immediately bagged up and taken out to the dumpster).
- Remove and destroy ALL identifying personal information (prescription label) from the medication container.
- Check for approved state and local collection programs or with area hazardous waste facilities. In certain states, you may be able to take your unused medications to your community pharmacy. Research shows that pharmacists are one of the most accessible healthcare professionals. As the medication experts on the healthcare team, pharmacists are available to guide you on how to properly dispose of your unused medications.

Creating a Learning Environment for Young Children

Creating a positive learning environment will enhance opportunities for young children to feel safe and supported. Child-care providers and preschool teachers realize that careful planning and classroom/home arrangement of space and equipment can facilitate learning experiences for young children.

The following is an excerpt from "Teaching Our Youngest."

A positive learning environment is a place where

- Children feel safe and well cared for.
- Children are valued as individuals.
- Children's needs for attention, approval, and affection are supported.
- Children can be helped to acquire a strong foundation in the knowledge and skills needed for school success.

Young children need preschool teachers and child care providers who

- Welcome all children to their classrooms/homes.
- Include children from various cultures.
- Include children whose first language is not English.
- Include children with disabilities.

Young children need preschool teachers and child care providers who take the time to work with them individually, in small groups, and/or the entire group


- To help them develop their cognitive and social skills.
- To help them develop their language abilities.
- To help them develop an interest in learning new things about the world.

Effective child care providers and preschool teachers

- Know when children can problem solve and figure out new ideas and concepts on their own and when it is important to explain things to them.
- Encourage children to participate in classroom activities and follow the school rules.
- Listen to what the children say and expand upon their language, building their vocabulary and background knowledge.
- Know when to teach directly, when to provide time for exploration and discovery, when to practice skills, and when to
 encourage creativity.
- Plan activities that have a purpose and that challenge children.
- Know how to help children learn to work together and to resolve their conflicts.
- Encourage children to respect each other's time and personal belongings.
- Provide many opportunities for conversations between and among children and with adults.
- Know how to establish and maintain order in the classroom/home but in a manner that permits the children to learn how to participate in and enjoy learning.
- Arrange the classroom/home in a way that enhances their work with children and how children spend their time.

TODD'S BEHAVIOR TOOLBOX

Transition times are the points in the day when children are asked to change activities. Some major transitions during the day include arrival, lunch, nap, outside time, and departure. These times of change are often accompanied by challenging behavior if they are not well-structured and planned. Chaotic transitions can lead to frustration for both the teachers and the children. There are some steps that can be taken that may lead to smoother transitions.

Minimize the number of transitions that require the whole group to do the same thing at the same time. For example, instead of telling the entire class to go get their coats on to go outside, pull one or two children out at a time to put on their coats while the rest of the class stays engaged in their activity. This reduces the amount of time that the children spend waiting for their turn, which should reduce challenging behavior.

Plan activities to keep the children engaged throughout the transition. Position a teacher at the door to engage children as they wait to go outside. Children may sing a song as they clean-up or march as they come in from outside. Select children to move to the next activity by different characteristics. For example, "If you are wearing a red shirt, you may go wash your hands." This reduces the number of children moving at one time and keeps the other children engaged as they listen to be called.

Finally, prepare children for the transition. Provide them with a warning before changing activities. Children may become frustrated if they do not have time to finish something or are not ready to move on. Tell the children what activity they will be doing next. Refer to the picture schedule and provide individual assistance to children that may need help.

Infant/Toddler News

In October, I was very fortunate to spend a week in Charleston, SC learning more about the Pikler Approach through the Pikler Intensive III Observation of Infants and Toddlers: Attention to Detail sponsored by the Pikler/Loczy Fund USA.

The Pikler Institute was established in 1946 by pediatrician Dr. Emmi Pikler. The City of Budapest commissioned Dr. Pikler to organize a home for infants and young children who were deprived of their parents until satisfactory living arrangements could be found. Dr. Pikler's concepts and practices included ideas on respecting the child as a person - where he/she is an active individual and is allowed to move freely in a safe environment.

This Intensive brought Anna Tardos, the daughter of Emmi Pikler, as a co-presenter. She was the last director of the Pikler Institute and holds the position of President of the Pikler-Loczy Association in Hungary. Anna's co-presenter was Agnes Szanto-Feder. She currently sits on the Board for the Pikler-Loczy Fund USA and is on the committee for the World Forum's Working Group for the Rights of Children in Children's Homes.

This Intensive brought together professionals working on behalf of children from 7 different states in the US as well as 9 different countries. I gained a lot of knowledge from this week, more than what I can write in a short article, but I would like for all infant and toddler caregivers to at least receive a few short tips that helps put the Pikler Approach into action.

- ✓ Never pick up an infant unexpectedly into your arms in a way that is startling for them.
- ✓ Treat the infant or toddler as an active participant in the caregiving process.
- ✓ Be relaxed and calm. Never hurry. Take value in the one-on-one interaction that takes places through caregiving routines.
- ✓ The value of self-initiated activity from the earliest age i.e. allowing plenty of time on the (baby-proofed) floor for uninterrupted exploration and play.
- ✓ The value of building a trusting relationship with a consistent caregiver who is respectful of the child's personality and needs. This involves sensitive observation of the child as well as slowing down and tuning in during the daily care giving routines of dressing, feeding, bathing, diaper changing and communicating what you are doing. Taking the time to observe our babies will teach us about them and their needs.



HELP! Is my billing payment adding up? Locating and Determining Daily Fees

How much do I owe you? How often do I need to pay you? If these are familiar questions asked by the parents whom you provide childcare services to – you need to read this article.

Child Care providers are responsible for I collecting fees from parents, which is not always an easy task. In order to know the amount that each parent is responsible to pay, you will need to have a copy of the Child Care Certificate or Provider Notification letter. The Child Care Certificate should be received directly from the parent- Section V. "Child Fee" lists the amount due beside each child's name. The Provider Notification Letter should be sent to you by mail, directly from the Family Resource Coordinator working with each family - | Section 1. "Daily Fee Amount" lists the amount due beside each child's name. The "Child Fee" or "Daily Fee Amount" indicates the amount each family should pay - per child, per full day. The daily fee will be the same for each child. If a family has more than three children needing child care, the fee will be assessed only for the three youngest children. Parents shall not be charged for more than three children.

Fees should be collected and paid at least monthly. Child Care Providers can decide when and how often to collect these fees (options include collecting fees daily, weekly, biweekly...etc.) Once fees are paid, providers are asked to provide receipts to parents upon request. If a parent fails to pay their daily fee, you can contact your local R&R office for assistance in collecting these fees. The provider must notify the R&R in writing no later than 30 days after the date payment was due. Once this information is received, the worker shall send notice to the parent indicating if payment is not made within 13 days, child care services will be terminated.

If you are struggling to convert part days to full days using the "Fee Collection Instructions Form", please contact your local R&R office for a billing retraining- we are always here to help.
